

## **E-Governance:**

E-Governance is considered key to better governance. Institutions around the world are initiating various e-governance initiatives for delivering more transparent, efficient and cost effective services for its stakeholders. Changing with the time, BGSBU I.T. Centre has initially conceptualized three main e-governance projects / initiatives viz. Examination, University Admission system and Recruitment Section. In this regard, objectives and benefits of various modules are mentioned.

### **1. Objectives of the e-Governance Initiatives at BGSBU**

In order to create efficiency, transparency and accountability in the system the following e-Governance initiatives are to be taken

- I. e-Gov Examination.
- II. e-Gov Administration.
- III. Development of requisite IT infrastructure at each University Campus / Department / Centre.
- IV. Introduction of online services for students, colleges / departments.
- V. Establishment of one Information Centre at each University affiliated college with appropriate infrastructure, connectivity and manpower

#### ***1.1 E-Governance of Admission System***

The e-governed system for management of the University admission processes shall automate the processes online with the following features:

- I. Shall ensure online submission of Applications forms for entrance tests.
- II. Academic Details shall be made available online for different stake holders of the University.
- III. Auto- Eligibility Check.
- IV. Campus Preferences.
- V. Auto Roll No Allocation.
- VI. Exam Centre Allocation.
- VII. Auto generation of e-Admit Cards.
- VIII. Form Printout & Fee Receipt.
- IX. Pay at any J&K Bank branch and online as well through payment gateway.

#### ***1.2 E-Governance of Examination System***

Under the e-governance of examination system, the following processes are to be E-governed.

- I. Pre-Conduct processes of examination viz. online submission of auto-verified / filled forms and acceptance, updating of online forms, fee reconciliation and e-admit cards.
- II. Post-Conduct processes of examination viz. e-governed system for auto roll number allocation, centre location and centre notification.

### **1.3 E-Governance of Recruitment System**

The e-governed system for management of the University recruitment processes shall automate the processes online with the following features:

- I. Shall ensure online submission of Applications forms for various advertised posts.
- II. Academic Details of candidates applying for the post.
- III. Auto- Eligibility Check regarding the eligibility based on the constraints set by the University.
- IV. Pay via online mode
- V. Form Printout & Fee Receipt
- VI. Campus Preferences
- VII. Auto Roll No Allocation for written tests (if any)
- VIII. Exam Centre Allocation
- IX. Auto generation of e-Admit Cards/Interview call letters
- X. Auto calculation of API's as per UGC Guidelines.

### **2. Challenges in E-Governance.**
