Submission of Online Scholarship applications under Central Sector Scheme "SCHOLARSHIPS FOR STUDENTS WITH DISABILITIES" for the year 2024-25.

Online applications are invited from the students eligible for above mentioned Scheme pursuing their, PG, UG, and Diploma Courses in the University. The Scheme being implemented by "THE DEPARTMENT OF EMPOWERMENT OF PERSONS WITH DISABILITIES, (DIVYANGJAN) MINISTRY OF SOCIAL JUSTICE AND EMPOWERMENT, GOVERNMENT OF INDIA". The scholarships are open only to Indian nationals. All the components of scholarships are open to students with benchmark disability i.e. 40% or more disability as defined in 'Rights of Persons with Disabilities Act, 2016. Not more than two children with disabilities of the same parents will be entitled to receive benefits of the scheme. In case the second child is a twin, the scholarship under the schemes will be admissible to the twin. Scholarship for studying in any class will be available for only one year. If a student has to repeat a class, she/he would not get scholarship for that class for a second (or a subsequent) year.

The grant of scholarship is subject to the condition that student does not receive any financial assistance in shape of scholarship/any emoluments, salary, stipend etc. from any other source during his/her course of study in the Institute. In case of receipt of any financial assistance from any other sources, the scholarship shall be discontinued and the entire amount of scholarship will have to be refunded and Strict action shall be taken against the student for furnishing any type of wrong/misleading information in respect of her eligibility and other details for getting the scholarship and for furnishing wrong/misleading information during the period of scholarship.

https://scholarships.gov.in/ Only Online applications under these Schemes will be accepted and no request for offline applications will be entertained. The details / eligibilities of the Scheme are mentioned below:

ELIGIBILITY FOR SCHOLARSHIP:

- 1. Online application form authenticated from concerned Dean/Head of the Department.
- 2. Student Photograph
- Family income from all sources should not be more than Rs. 2.5 lakh per annum during the current financial year. A valid income certificate issued by State / UT Government need to be enclosed.
- 4. Not more than two children with disabilities of the same parents will be entitled to receive benefits of the scheme. In case the second child is a twin, the scholarship under the schemes will be admissible to the twin.
