Subject: Your proposal dated 02/01/2017 regarding transfer and allotment of Pir Pal Café to the School of Management Studies & Economics.

Sir,

Pursuant to the recommendation of Canteen Allotment Committee and approval of the Competent Authority Pir Pal Café is hereby transferred to at the disposal of School of Management Studies & Economics for running the same by the Students of 1st semester as start-up project & venture capital investments learning projects under the guidance & responsibility of the Dean, School of Management Studies & Economics initially for a period of one year w.e.f. 01/04/2017, subject to the following terms and conditions in addition to those already mentioned in the Proposal submitted by the School (Copy enclosed):

1. The Chief Proctor and the Dean, School of Management Studies & Economics shall be solely responsible for all matters vis-à-vis timings, discipline and security in and around of the cafeteria.
2. The Dean, School of Management Studies & Economics shall deposit 50% of the annual profit in the Finance Section under intimation to the Estates Section at the end of every financial year. However, the electricity charges shall be deposited against the bills raised by the Electrical Wing of the University on monthly basis.
3. Sales accounts of the cafeteria shall be monitored by the team of teachers as notified by the Dean, School of Management Studies & Economics on quarterly basis.
4. Promoters of the cafeteria shall hold only 50% of the annual profit earned after the end of the financial year.
5. Out of the remaining 50% annual profit, 25% share will be given to the School of Management Studies for developmental activities of the Department.
6. The Dean shall ensure availability of supplies / commodities of good quality, hygiene, waste disposal and maintenance of high standards of housekeeping & Hospitality.
7. The Estates Section shall handover all available infrastructures in the Pir pal Cafe to the Dean School of Management Studies against proper receipt.
8. The Dean shall follow all codal formalities for proper operation of Pir pal Café.
